GAME PLAY DIRECTIVE

Issued: September 16, 2007 Revised: June 27, 2010 Revised: December 23, 2011 Addendum: March 30, 2013 2nd Addendum: March 29, 2014 This directive is designed to provide a guideline for the conduct of an on-line, instant-win promotional feature for Easy 5, to be designated "ezmatch". In the event of conflict between the provisions of this and any other directive or other publication of the Corporation concerning the conduct of ezmatch, the provisions of this directive shall govern.

General Provisions

- (a) **ez**match is an instant-win promotional feature associated with Easy 5 that costs \$1.00 per play in addition to the cost of the Easy 5 ticket. A player selecting **ez**match will receive five (5) **ez**match numbers printed below the Easy 5 numbers on the ticket, along with a corresponding instant prize amount for each number. If any of the **ez**match numbers matches any of the Easy 5 numbers, the player will instantly win the corresponding amount shown for that **ez**match number. Players can match up to five (5) **ez**match numbers per ticket.
- (b) A player may play **ez**match by telling the retailer or by submitting a completed Easy 5 playslip with a mark placed inside the **ez**match box.
- (c) Easy 5 tickets with the **ez**match feature may not be canceled.
- (d) Each board played with **ez**match will be printed on a separate ticket. When a player purchases a multiboard Easy 5 ticket with the **ez**match option, separate tickets with separate **ez**match numbers for each Easy 5 board will be printed by the terminal. On a multidraw ticket, only one **ez**match play per Easy 5 board may be purchased.
- (e) The sale of official Easy 5 tickets with the **ez**match option may be conducted only by such retailers as the President shall license pursuant to Corporation regulations, rules, policies and directives for on-line retailer licensing.
- (f) The President may authorize the sale of an official Easy 5 ticket with the **ez**match option at a discount for promotional purposes. The President may also authorize the production and distribution of tickets at no cost to the recipient, for promotional purposes.

Prize Payouts and Odds

The prize payment structure and probabilities of winning (probabilities being expressed as "odds" of winning, as that term is applied in common usage in the lottery industry) are as follows:

The **ez**match prize structure is composed of a series of grids containing 100,000 plays available for purchase in each grid, with a total prize payout of 60.35%. The **ez**match prize structure grid will be replaced automatically with an identical grid when the top tier prizes are exhausted.

Other Requirements

- (a) Ticket Responsibility, Ticket Validation Requirements, and Procedure for Claiming and Payment of Prizes are contained in the Easy 5 Game Play Directive and are applicable to Easy 5 tickets with the **ez**match option.
- (b) **ez**match prizes may be claimed immediately after the ticket is purchased. For prizes claimed before the Easy 5 drawing date on the ticket, a player will be issued an exchange ticket containing the same Easy 5 numbers. The player has the sole responsibility for assuring the receipt of an exchange ticket and for verifying the accuracy and condition of the data printed on the exchange ticket at the time of claiming the **ez**match prize.
- (c) For any **ez**match prize claimed after the Easy 5 drawing date, the prize will be combined with any Easy 5 winnings from that ticket.
- (d) **ez**match prizes must be claimed within 180 days of the first drawing date on the Easy 5 ticket.
- (e) No interest shall be paid with respect to any **ez**match prize claim.
- (f) Prize monies allocated for the payment of **ez**match winning tickets shall be retained by the Corporation for payment to the ticket holder or holders entitled thereto. Any prize monies remaining unclaimed at the conclusion of the 180 day claim period shall be added to the unclaimed prize funds for future prize award, as provided by law.

(g) In purchasing a ticket, the purchaser agrees to comply with, and abide by, Louisiana State Law and all rules, regulations, policies, directives and final decisions of the lottery, and all procedures established by the President for the conduct of the game.

Effective Date

This ezmatch Play Directive shall become effective at 12:00 a.m., Friday, December 23, 2011.
