“TOUCHDOWN SAINTS”**

“TOUCHDOWN SAINTS” tickets shall be made available for sale at the discretion of the President of the Louisiana Lottery Corporation and shall continue until the President publicly announces the termination date. This Directive shall govern Play of the game, except to the extent that it may be amended or superseded by subsequent directive(s). The price of each ticket shall be three dollars (\$3.00) unless authorized by the President at a discount for promotional purposes.

Each ticket has one (1) game that consists of twelve (12) YOUR FOOTBALL NUMBERS Play Symbols, twelve (12) Prize Symbols, eleven (11) YOUR WINNING NUMBERS Play Symbols, and one (1) MULTIPLIER NUMBER Play Symbol.

HOW TO WIN:

Match any of YOUR WINNING NUMBERS to YOUR FOOTBALL NUMBERS, win prize shown for that number. Multiply your winnings by the MULTIPLIER number in the goal post.

The Louisiana Lottery Corporation will conduct three (3) Second-Chance Drawings to award ten (10) 2023 Saints Prize Packages, one (1) Saints 2024 Season Prize Package, and twenty-seven (27) Official Autographed Saints Merchandise Prizes as set forth in the **Louisiana Lottery SAINTS 2nd-Chance Drawing Directive**. To enter, players mail in at least \$10 worth of any non-winning Saints-branded 2023 instant-win tickets, **\$5 NEW ORLEANS SAINTS** (game #1509) scratch-off tickets and/or **\$3 TOUCHDOWN SAINTS** (game #100248) Fast Play tickets with their name, address, email and phone number on the back of the tickets to the designated Louisiana Lottery Saints 2nd-Chance Drawing address as stated in the **Louisiana Lottery SAINTS 2nd-Chance Drawing Directive**. Players may enter multiple times, but each entry must be mailed separately. Entrants may only win one (1) prize per drawing. The odds of being selected in the **Louisiana Lottery SAINTS 2nd-Chance Drawing** will depend on the number of entries received for each drawing.

By entering the second-chance drawing, entrants grant the Louisiana Lottery permission to use their name, images and city of residence in its publicity efforts should their entry be selected as a prize winner.

Saints marks and logos are used with permission of the New Orleans Saints. The Louisiana Lottery Corporation is solely responsible for conducting and administering the **NEW ORLEANS SAINTS** and **TOUCHDOWN SAINTS** instant-win games and related drawings. The National Football League, its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives and employees (collectively, the “NFL Entities”) will have no liability or responsibility for any claim arising in connection with participation in this lottery or the prize awarded. The NFL Entities have not offered or sponsored this lottery in any way.

DEFINITIONS

- a) **Lottery** means The Louisiana Lottery Corporation.
- b) **President** means the President of the Louisiana Lottery Corporation or any other person to whom the President's authority is lawfully delegated.
- c) **Instant Terminal Game** means a game which is played using ticket-generating terminals linked to a central computer, whereby a player can immediately determine whether the player has won a prize.
- d) **Fast Play Games** means a series of Instant Terminal Games offered by the corporation.
- e) A **Pool** shall consist of 240,000 tickets. A new pool shall be opened when all top prizes are claimed or at the discretion of the President.
- f) **Ticket Number** means the 35-digit number imaged on the face of every ticket.
- g) **Symbols:**

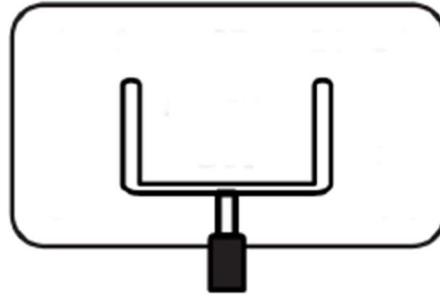

REDEMPTION

Four (4) Plaza Level Sideline season tickets for the 2023 Saints football season (pre-season, regular, and post-season home games); four (4) 2023 pre-game field passes (pre-season and regular season home games only); 2023 season parking pass (pre-season, regular, and post-season home games); tour of Saints Practice Facility for up to four (4) people including lunch in Team Cafeteria and opportunity to view a team practice; Limo transportation to/from Saints facility if the distance is within 75 miles of Saints facility (if the distance is beyond 75 miles of the Saints facility, hotel accommodations will be provided for 1 night - 2 rooms - in lieu of limo service); Federal and State withholdings paid on the winner's behalf. Saints Prize Package winners will be notified by mail/phone and a Winner Claim Form will be sent to the winner within two (2) business days of the Second-Chance Drawing. The winners must return the completed Winner Claim Form and required documentation to the Lottery within five (5) business days of receipt of notification or their prize will be reassigned. The winner has the responsibility of notifying the Lottery of any contact information or address change in a timely manner.

A Saints Prize Package may be transferred one (1) time but may not be sold. The transfer must be requested in writing (e-mail request acceptable) by the prize winner no later than 10 business days prior to the event, and the transfer must be approved by the Lottery. The approved designee must be at least 21 years of age. The transfer request must include the name and age of the person to receive the prize. If someone other than the prize winner (or approved designee) appears at the designated game, the Lottery reserves the right to refuse entry to the event. If the transfer is approved, the owner of the ticket claiming the Saints Prize Package will be responsible for Federal and State taxes as required by law. In the event of a prize transfer, the \$500 spending cash portion of the prize will be paid to the owner of the ticket claiming the Saints Prize Package. Saints Prize Package winners, designees, and their guests agree to adhere to all Saints policies related to the prize experience, including but not limited to adhering to ticket media terms and conditions. All elements of Saints Prize Packages including limo service, hotel

accommodation, pre-game field or entertainment passes, parking passes and Saints game or suite tickets may only be used by the Saints Prize Package winners (or approved designee) and their guests.

Saints Prize Package winners or designees must present a valid picture ID and a valid credit card for incidentals to check into the hotel where applicable. The Saints Prize Packages do not include: transportation to New Orleans, insurance, gratuities, meals, parking fees, alcoholic beverages, any items not specified and personal expenses such as telephone calls, valet service, room service, mini-bar, laundry, etc.

The travel portion of the Saints Prize Packages is for the designated trip and may not be rescheduled. Failure to check into the hotel for the designated night (where applicable) will result in forfeiture of the use of that portion of the prize. The hotel portion (if included in prize) of Saints Prize Packages may only be used by the Saints Prize Package winners (or approved designee) and their guests.

Official Autographed Saints Merchandise Prizes may be shipped directly to the winners using the address provided on the entry drawn. If a Post Office Box address is provided for the mailing address, the Lottery will make all reasonable efforts to reach the winner by the telephone number or email address provided on the entry to obtain a mailing address. If not provided or the winner cannot be reached within seven (7) business days, the Lottery will award the prize to the next eligible alternate. In the event that an Official Autographed Saints Merchandise Prize is returned as undeliverable, the Lottery will make all reasonable efforts to locate the winner. If the Lottery is unable to locate the winner within ten (10) calendar days of return of the merchandise, the Lottery will award the prize to the next eligible alternate.

In the unlikely event that the Lottery is unable to fulfill a stated second-chance prize or a portion of a second-chance prize due to circumstances beyond its control, a prize of equal or greater value will be substituted at the Lottery's sole discretion.

Winners of Saints Prize Packages and Official Autographed Saints Merchandise Prizes shall not have the option to receive cash payment in lieu of the designated prize. The Lottery has no responsibility to reimburse winners for any forfeiture of any portion of the prize.

The Lottery, subject to the Child Support Arrearage withholding requirements and unforeseen events, reserves the right to award a cash prize equivalent to the value of a Saints Prize Package in lieu of the prize. In the event the Lottery awards a cash prize equivalent due to Child Support Arrearage withholding requirements, the Saints Prize Package may be awarded to the next eligible alternate.

DETERMINATION OF INSTANT PRIZE WINNERS

The determination of instant prize winners is subject to validation pursuant to the paragraphs below entitled Claim Period and Ticket Validation Requirements.

- a)** The holder of a ticket shall be entitled to a prize of \$3.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$3 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- b)** The holder of a ticket shall be entitled to a prize of \$5.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$5 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- c)** The holder of a ticket shall be entitled to a prize of \$10.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$2 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 5X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- d)** The holder of a ticket shall be entitled to a prize of \$10.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$5 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 2X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- e)** The holder of a ticket shall be entitled to a prize of \$10.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$10 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- f)** The holder of a ticket shall be entitled to a prize of \$15.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$5 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 3X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- g)** The holder of a ticket shall be entitled to a prize of \$15.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$15 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- h)** The holder of a ticket shall be entitled to a prize of \$20.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$5 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 4X play symbol appears in the MULTIPLIER play area on the face of the ticket.

- i) The holder of a ticket shall be entitled to a prize of \$20.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$10 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 2X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- j) The holder of a ticket shall be entitled to a prize of \$20.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$20 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- k) The holder of a ticket shall be entitled to a prize of \$25.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$5 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 5X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- l) The holder of a ticket shall be entitled to a prize of \$25.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$25 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- m) The holder of a ticket shall be entitled to a prize of \$50.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$10 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 5X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- n) The holder of a ticket shall be entitled to a prize of \$50.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$25 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 2X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- o) The holder of a ticket shall be entitled to a prize of \$50.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$50 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- p) The holder of a ticket shall be entitled to a prize of \$100.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$20 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 5X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- q) The holder of a ticket shall be entitled to a prize of \$100.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$100 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.

- r) The holder of a ticket shall be entitled to a prize of \$200.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$100 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 2X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- s) The holder of a ticket shall be entitled to a prize of \$200.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$50 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 4X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- t) The holder of a ticket shall be entitled to a prize of \$200.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$200 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- u) The holder of a ticket shall be entitled to a prize of \$1,000.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$200 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 5X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- v) The holder of a ticket shall be entitled to a prize of \$1,000.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$1,000 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.
- w) The holder of a ticket shall be entitled to a prize of \$15,000.00 if one (1) of the twelve (12) YOUR FOOTBALL NUMBERS matches any of the YOUR WINNING NUMBERS and the \$15,000 prize symbol appears for that YOUR FOOTBALL NUMBER **PLUS** the 1X play symbol appears in the MULTIPLIER play area on the face of the ticket.

TICKET RESPONSIBILITY

A Fast Play Game ticket is payable to the person presenting the ticket for payment.

The Lottery shall not be responsible for lost or stolen Fast Play Game ticket(s).

The Lottery shall not be responsible for tickets claimed in error or redeemed in error at a sales agent location.

A Fast Play Game ticket is a bearer instrument until signed.

CLAIM PERIOD

All prizes for this Fast Play Game must be claimed no later than ninety (90) days from and after the announced end of sales date for this game. Any prize not claimed in the manner described in the Directive shall be forfeited.

All prizes of the **Louisiana Lottery SAINTS 2nd-Chance Drawing** must be claimed as outlined in the paragraphs above entitled **Louisiana Lottery SAINTS 2nd-CHANCE DRAWING**.

TICKET VALIDATION REQUIREMENTS

To be a valid “TOUCHDOWN SAINTS” Fast Play Game ticket, all of the following requirements must be met:

- 1) Exactly twelve (12) YOUR FOOTBALL NUMBERS Play Symbols, twelve (12) Prize Symbols, eleven (11) YOUR WINNING NUMBERS Play Symbols, one (1) MULTIPLIER NUMBER Play Symbol and one (1) Ticket Number must appear on the face of the ticket;
- 2) The twelve (12) YOUR FOOTBALL NUMBERS Play Symbols, twelve (12) Prize Symbols, eleven (11) YOUR WINNING NUMBERS Play Symbols, one (1) MULTIPLIER NUMBER Play Symbol and one (1) Ticket Number must meet all of the following criteria:
 - a. be printed in black ink in its entirety and be fully legible;
 - b. be right-side-up and not reversed in any manner;
 - c. be one (1) or more of those described in the previous paragraphs entitled DEFINITIONS;
 - d. be printed in the specified font size and correspond precisely to the specifications for this Fast Play Game on file at the Lottery;

Any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;

- 3) Sufficient validation data must be present and the play data must correspond with the data reflected in the Corporation’s computer records relating to production of the ticket;
- 4) The ticket must be intact; any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;
- 5) The ticket must not be mutilated, altered, unreadable, reconstructed or tampered with in any manner;
- 6) The ticket must not be counterfeit;
- 7) The ticket must have been issued by a licensed retailer or self-service vending machine in an authorized manner on official paper stock;
- 8) The ticket data, ticket number and validation data of an apparent winning ticket must appear on the Corporation’s computer records and must not have been previously paid;

- 9) The ticket must not be blank or partially blank, misregistered, defective, printed or produced in error;
- 10) The printing must be regular in every respect and correspond precisely with the artwork for this game on file at the Lottery;
- 11) The ticket must pass all validation tests of the Lottery;

Any ticket not passing all the validation tests in this section may be decreed void and ineligible for any prize. In the event a defective ticket is purchased, the sole responsibility and/or liability of the Lottery shall be the replacement of the defective ticket with an unplayed ticket(s) of equivalent sales price from any current lottery game.

CHILD SUPPORT ARREARAGE

According to Louisiana Revised Statutes 47:9026, the Louisiana Lottery is required to withhold outstanding child support arrearage from lottery winners. If the information submitted by the Department of Child and Family Services indicates that a prize winner owes child support, the amount due will be deducted from the winnings and the remainder, if any, will be remitted to the winner. Refer to the LLC's Special Rules and Regulations on Payment of Prizes for additional information regarding this matter.

The Lottery, subject to the Child Support Arrearage withholding requirements, reserves the right to award a cash prize equivalent to the value of a Saints Prize Package in lieu of the prize. In that event, the Saints Prize Package may be awarded to the next eligible alternate.

DISPUTES

In the event a dispute between the Lottery and the ticket presenter occurs as to whether the ticket is a winning ticket and the ticket prize is not paid, the President may, solely at his/her option, replace the disputed ticket with an unplayed ticket (or tickets of equivalent sales price from another current Lottery game). This shall be the sole and exclusive remedy of the presenter of the ticket in the event of such disputes.

GOVERNING LAW

In purchasing a ticket, the purchaser agrees to comply with and abide by Louisiana State Law and all rules and regulations, directives and final decisions of the Lottery and all procedures established by the President for the conduct of the game.

PURCHASE AND PRIZE RESTRICTIONS

No Fast Play Game ticket shall be purchased by and no prize paid to any member of the Board of Directors, officer or employee of the Lottery or to any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any such person.

Players do not have the ability to select numbers or play symbols.

Fast Play Game tickets may only be sold to persons 21 years of age or older.

A Fast Play Game ticket may not be cancelled.

TERMINATION OF THE GAME


The President at any time may announce an end of sales date for the game. No tickets for this game shall be generated by retailer locations following that date.

RETAILER CONDUCT

Retailers shall only produce Fast Play Game tickets at time requested by customer. Retailers are prohibited from printing Fast Play Game tickets in advance.

Retailers are prohibited from playing Fast Play Game tickets using any method other than fair chance or contrary to the principle that every ticket has an equal and random chance of winning a prize.

Retailers and retailers' employees are prohibited from placing their own or any other name on any ticket not purchased and redeemed by said retailer or employee.
