“GOLDEN NUGGET® \$100,000” tickets shall be made available for sale at the discretion of the President of the Louisiana Lottery Corporation and shall continue until the President publicly announces the termination date. The ticket purchaser will remove the scratch-off material to reveal fifteen (15) YOUR NUMBERS play symbols and captions, five (5) WINNING NUMBERS play symbols and captions, and fifteen (15) prize symbols and captions.

DEFINITIONS

- a) **Lottery** means The Louisiana Lottery Corporation.
- b) **President** means the President of the Louisiana Lottery Corporation or any other person to whom the President's authority is lawfully delegated.
- c) A **Pack** shall consist of 50 fanfolded tickets bearing a common pack number.
- d) **Pack-Ticket Number** means the thirteen (13) digit code printed in black standard pack-ticket number font located on the back of the ticket in the format of GGGG-PPPPPP-TTT. The first four (4) digits are the Game Identifier, the fifth through tenth digits are the Pack Number, the eleventh through thirteen digits are the Ticket Number.
- e) **Validation Number** means the ten (10) digit number imaged on the face of every ticket and covered with scratch-off material. The Validation Number shall be printed in standard Validation Number font.
- f) **PDF417 Bar Code** means the Bar Code printed on the front of the ticket and covered with scratch-off material. This Bar Code will identify it as a winner or non-winner.

REDEMPTION

Golden Nugget® VIP Prize Package Winner Notification & Verification

PROHIBITED/SELF-EXCLUDED PERSONS ARE NOT ELIGIBLE TO PARTICIPATE IN THE SECOND CHANCE PROMOTION. Winning Entries and Alternates drawn will be screened prior to notification. The Lottery will verify that the winner is at least 21 years of age. If any winner is determined to be under 21 years of age, they will be disqualified, and their prize reassigned to the next eligible Alternate drawn. The Lottery will provide the names and contact details of Winning Entries and Alternates to Alchemy3 Inc. for cross-referencing against the prohibited/self-excluded list. If a Winning Entry or Alternate is found on this list, the entry will be disqualified and the next eligible Alternate drawn will advance.

Once the screening is complete, the Golden Nugget® VIP Prize Package Winners (“Prize Package Winners”) will be notified by mail/phone and a Winner Claim Form and Guest Form will be sent to the Prize Package Winners within two (2) business days. The Prize Package Winners must return the completed Winner Claim Form, Guest Form and required documentation, including a copy of a valid photo ID verifying age of the Prize Package Winner and the Guest, to the Lottery within seven (7) business days of receipt of notification, or their prize will be reassigned to the next eligible Alternate drawn. The Lottery will provide the name and contact details of Guests to Alchemy3 Inc. for cross-referencing against the prohibited/self-excluded list. If a Guest appears on this list,

another name and contact information may be submitted by the Prize Package Winner for the Guest, subject to prohibited/self-exclusion screening and age verification.

A Prize Package Winner whose Claim Form has been cleared by prohibited/self-exclusion screening and age verification, may, at their discretion, make a **one-time-only request in writing no later than January 10, 2025**, to designate a proxy (“Proxy”) to take the trip and participate in the Golden Nugget® Grand Prize Event in their stead. If a potential Guest is found to be under 21 years of age or on the prohibited/self-excluded list, another name may be submitted for the Guest, subject to prohibited/self-exclusion screening and age verification. If a potential Proxy is found on the prohibited/self-exclusion list, the Proxy request will not be approved, and the Lottery may, at its sole discretion, accept another name for the Proxy, subject to prohibited/self-exclusion screening and age verification. In the event that a winner becomes unable to appear at the VIP Prize event AFTER the January 10, 2025 deadline to appoint a proxy, the Lottery will assign a proxy to participate in the Grand Prize Event in the place of the Prize Package Winner and the Trip portion of the prize will be forfeited, but the Prize Package Winner will still be eligible for the cash portion of the prize.

 - (c) be one (1) or more of those described in the previous paragraphs entitled DEFINITIONS;

Any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;

- (11) The ticket must not be blank or partially blank, misregistered, defective, printed or produced in error;
- (12) The display printing must be regular in every respect and correspond precisely with the artwork for this game on file at the Lottery;

Retailers are prohibited from exchanging Packs with other Retailers.

Retailers are prohibited from playing Scratch-off Game tickets using any method other than fair chance or contrary to the principle that every ticket has an equal and random chance of winning a prize.

Retailers and retailers' employees are prohibited from placing their own or any other name on any ticket not purchased and redeemed by said retailer or employee.
