"NEW ORLEANS SAINTS" tickets shall be made available for sale at the discretion of the President of the Louisiana Lottery Corporation and shall continue until the President publicly announces the termination date. This Directive shall govern play of the game, except to the extent that it may be amended or superseded by subsequent directive(s). The price of each ticket shall be five dollars (\$5.00) unless authorized by the President at a discount for promotional purposes.

Each ticket has one (1) game that consists of: five (5) WINNING NUMBERS play symbols, fifteen (15) YOUR NUMBERS play symbols and fifteen (15) prize symbols. The ticket purchaser will remove the scratch-off material to reveal five (5) WINNING NUMBERS play symbols and captions, fifteen (15) YOUR NUMBERS play symbols and captions, and fifteen (15) prize symbols and captions.

Match any of YOUR NUMBERS to any WINNING NUMBER, win PRIZE shown. Get a "CASHSTACK" symbol, win DOUBLE the PRIZE shown. Get a "FOOTBALL" symbol, win TRIPLE the PRIZE shown!

The Louisiana Lottery Corporation will conduct three (3) Second-Chance Drawings to award ten (10) 2022 Saints Prize Packages, one (1) Saints 2023 Season Prize Package, and twenty-seven (27) Official Autographed Saints Merchandise Prizes as set forth in the **Louisiana Lottery SAINTS 2nd-Chance Drawing Directive**. To enter, players mail in at least \$10 worth of any non-winning Saints-branded 2022 instant-win tickets, **\$2 SAINTS GAMEDAY** (game #1452), **\$5 NEW ORLEANS SAINTS** (game #1453) scratch-off tickets and/or **\$5 SAINTS** (game #100226) Fast Play tickets with their name, address, and phone number on the back of the tickets to the designated Louisiana Lottery Saints 2nd-Chance Drawing address as stated in the **Louisiana Lottery SAINTS 2nd-Chance Drawing Directive**. The NFL Entities have not offered or sponsored this lottery in any way.

DEFINITIONS

- (a) **Lottery** means The Louisiana Lottery Corporation.
- (b) **President** means the President of the Louisiana Lottery Corporation or any other person to whom the President's authority is lawfully delegated.
- (c) A **Pack** shall consist of fifty (50) fanfolded tickets bearing a common pack number.
- (d) **Pack-Ticket Number** means the thirteen (13) digit code printed in black standard pack-ticket number font located on the back of the ticket in the format of GGGG-PPPPPP-TTT. The first four (4) digits are the Game Identifier, the fifth through tenth digits are the Pack Number, and the eleventh through thirteenth digits are the Ticket Number.
- (e) **Validation Number** means the ten (10) digit number imaged on the face of every ticket and covered with scratch-off material. The Validation Number shall be printed in standard Validation Number font.
- (f) **PDF417 Bar Code** means the Bar Code printed on the front of the ticket and covered with scratch-off material. This Bar Code will identify it as a winner or non-winner.

REDEMPTION

Tickets winning a cash prize may be redeemed at any lottery office or retailer sales location during the official sales period for this game, but no later than ninety (90) days after the announced end of sales for this game. Tickets winning a low or mid-tier prize may be redeemed at any participating lottery retail location. Any cash prize may be redeemed at any lottery regional office or at lottery headquarters in Baton Rouge, within the claim period noted above. Four (4) Plaza Level Sideline season tickets for the 2023 Saints football season (pre-season, regular, and post-season home games); four (4) 2023 pre-game field passes (pre-season and regular season home games only); 2023 season parking pass (pre-season, regular, and post-season home games); tour of Saints Practice Facility for up to four (4) people including lunch in Team Cafeteria and opportunity to view a team practice; Limo transportation to/from Saints facility if the distance is within 75 miles of Saints facility (if the distance is beyond 75 miles of the Saints facility, hotel accommodations will be provided for 1 night - 2 rooms - in lieu of limo service); Federal and State withholdings paid on the winner's behalf. Individual Value: \$100 (One hundred dollars)

Saints Prize Package winners will be notified by mail/phone and a Winner Claim Form will be sent to the winner within two (2) business days of the Second-Chance Drawing. The winners must return the completed Winner Claim Form and required documentation to the Lottery within five (5) business days of receipt of notification or their prize will be reassigned. The winner has the responsibility of notifying the Lottery of any contact information or address change in a timely manner.

A Saints Prize Package may be transferred one (1) time but may not be sold. The transfer must be requested in writing (e-mail request acceptable) by the prize winner no later than 10 business days prior to the event, and the transfer must be approved by the Lottery. The approved designee must be at least 21 years of age. The transfer request must include the name and age of the person to receive the prize. If someone other than the prize winner (or approved designee) appears at the designated game, the Lottery reserves the right to refuse entry to the event. If the transfer is approved, the owner of the ticket claiming the Saints Prize Package will be responsible for Federal and State taxes as required by law. In the event of a prize transfer, the \$500 spending cash portion of the prize will be paid to the owner of the ticket claiming the Saints Prize Package. Saints Prize Package winners, designees, and their guests agree to adhere to all Saints policies related to the prize experience, including but not limited to adhering to ticket media terms and conditions. All elements of Saints Prize Packages including limo service, hotel accommodation, pre-game field or entertainment passes, parking passes and Saints game or suite tickets may only be used by the Saints Prize Package winners (or approved designee) and their guests.

Saints Prize Package winners or designees must present a valid picture ID and a valid credit card for incidentals to check into the hotel where applicable. The Saints Prize Packages do not include: transportation to New Orleans,

insurance, gratuities, meals, parking fees, alcoholic beverages, any items not specified and personal expenses such as telephone calls, valet service, room service, mini-bar, laundry, etc.

The travel portion of the Saints Prize Packages is for the designated trip and may not be rescheduled. Failure to check into the hotel for the designated night (where applicable) will result in forfeiture of the use of that portion of the prize. The hotel portion (if included in prize) of Saints Prize Packages may only be used by the Saints Prize Package winners (or approved designee) and their guests.

Official Autographed Saints Merchandise Prizes may be shipped directly to the winners using the address provided on the entry drawn. In the event that an Official Autographed Saints Merchandise Prize is returned as undeliverable, the Lottery will make all reasonable efforts to locate the winner. In the event that the Lottery is unable to locate the winner within thirty (30) calendar days of return of the merchandise, the Lottery will award the prize to the next eligible alternate.

Due to ever-changing COVID-19-related restrictions, some elements of the experience prizes are subject to change. In the unlikely event that the Lottery is unable to fulfill a stated second-chance prize or a portion of a second-chance prize due to circumstances beyond its control, a prize of equal or greater value will be substituted at the Lottery's sole discretion. Local, state and league mask or vaccination mandates in effect at the time of prize experience will apply.

Winners of Saints Prize Packages and Official Autographed Saints Merchandise Prizes shall not have the option to receive cash payment in lieu of the designated prize. The Lottery has no responsibility to reimburse winners for any forfeiture of any portion of the prize.

The Lottery, subject to the Child Support Arrearage withholding requirements and unforeseen events, reserves the right to award a cash prize equivalent to the value of a Saints Prize Package in lieu of the prize. In the event the Lottery awards a cash prize equivalent due to Child Support Arrearage withholding requirements, the Saints Prize Package will be awarded to the next eligible entry drawn.

DETERMINATION OF INSTANT PRIZE WINNERS

The determination of instant prize winners is subject to validation pursuant to the paragraphs below entitled Claim Period and Ticket Validation Requirements.

- a) The holder of a ticket shall be entitled to a prize of a FREE \$5 TICKET if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a TICKET prize symbol and confirming TICKET prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- b) The holder of a ticket shall be entitled to a prize of \$10.00 if the “CASHSTACK” play symbol and confirming “DOUBLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$5.00 prize symbol and confirming FIVE prize symbol caption appear for that YOUR NUMBER in the exposed play area.
- c) The holder of a ticket shall be entitled to a prize of \$10.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$10.00 prize symbol and confirming TEN prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.

- f) The holder of a ticket shall be entitled to a prize of \$20.00 if four (4) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$5.00 prize symbol and confirming FIVE prize symbol caption appear for each matching YOUR NUMBER in the exposed play area.
- g) The holder of a ticket shall be entitled to a prize of \$20.00 if the “CASHSTACK” play symbol and confirming “DOUBLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$10.00 prize symbol and confirming TEN prize symbol caption appear for that YOUR NUMBER in the exposed play area.

- o) The holder of a ticket shall be entitled to a prize of \$50.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$50.00 prize symbol and confirming FIFTY prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- p) The holder of a ticket shall be entitled to a prize of \$75.00 if the “FOOTBALL” play symbol and confirming “TRIPLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$25.00 prize symbol and confirming TWY FIV prize symbol caption appear for that YOUR NUMBER in the exposed play area.
- q) The holder of a ticket shall be entitled to a prize of \$75.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$75.00 prize symbol and confirming SVY FIV prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- r) The holder of a ticket shall be entitled to a prize of \$100.00 if fifteen (15) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$5.00 prize symbol and confirming FIVE prize symbol caption appear for twelve (12) matching YOUR NUMBERS **and** a \$15.00 prize symbol and confirming FIFTEEN prize symbol caption appear for two (2) matching YOUR NUMBERS **and** a \$10.00 prize symbol and confirming TEN prize symbol caption appear for one (1) matching YOUR NUMBER in the exposed play area.

- s) The holder of a ticket shall be entitled to a prize of \$100.00 if ten (10) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$10.00 prize symbol and confirming TEN prize symbol caption appear for each matching YOUR NUMBER in the exposed play area.
- t) The holder of a ticket shall be entitled to a prize of \$100.00 if the “FOOTBALL” play symbol and confirming “TRIPLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$30.00 prize symbol and confirming THIRTY prize symbol caption appear for that YOUR NUMBER **plus** one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$10.00 prize symbol and confirming TEN prize symbol caption appear for one (1) matching YOUR NUMBER in the exposed play area.
- u) The holder of a ticket shall be entitled to a prize of \$100.00 if the “CASHSTACK” play symbol and confirming “DOUBLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$50.00 prize symbol and confirming FIFTY prize symbol caption appear for that YOUR NUMBER in the exposed play area.
- v) The holder of a ticket shall be entitled to a prize of \$100.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- w) The holder of a ticket shall be entitled to a prize of \$250.00 if five (5) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$50.00 prize symbol and confirming FIFTY prize symbol caption appear for each matching YOUR NUMBER in the exposed play area.
- x) The holder of a ticket shall be entitled to a prize of \$250.00 if the “CASHSTACK” play symbol and confirming “DOUBLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for that YOUR NUMBER **plus** one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$50.00 prize symbol and confirming FIFTY prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- y) The holder of a ticket shall be entitled to a prize of \$250.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$250 prize symbol and confirming 2HUNFTY prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- z) The holder of a ticket shall be entitled to a prize of \$500.00 if the “CASHSTACK” play symbol and confirming “DOUBLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for that YOUR NUMBER **plus** the “FOOTBALL” play symbol and confirming “TRIPLE” play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for that YOUR NUMBER in the exposed play area.
- aa) The holder of a ticket shall be entitled to a prize of \$500.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$500 prize symbol and confirming 5HUN prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.

- bb) The holder of a ticket shall be entitled to a prize of \$1,000.00 if fifteen (15) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$50.00 prize symbol and confirming FIFTY prize symbol caption appear for ten (10) matching YOUR NUMBERS **and** a \$100 prize symbol and confirming 1HUN prize symbol caption appear for five (5) matching YOUR NUMBERS in the exposed play area.
- cc) The holder of a ticket shall be entitled to a prize of \$1,000.00 if ten (10) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for each matching YOUR NUMBER in the exposed play area.
- dd) The holder of a ticket shall be entitled to a prize of \$1,000.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$1,000 prize symbol and confirming 1THOU prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- ee) The holder of a ticket shall be entitled to a prize of \$100,000.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$100,000 prize symbol and confirming 100THOU prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.

TICKET RESPONSIBILITY

- (a) A Scratch-off Game ticket is payable to the person presenting the ticket for payment.
- (b) The Lottery shall not be responsible for lost or stolen Scratch-off Game ticket(s).
- (c) The Lottery shall not be responsible for tickets claimed in error or redeemed in error at a sales agent location.

CLAIM PERIOD

All prizes for this Scratch-off Game must be claimed no later than ninety (90) days from and after the announced end of sales date for this game. Any prize not claimed in the manner described in the Directive and on the back of each ticket shall be forfeited.

All prizes of the **Louisiana Lottery SAINTS 2nd-Chance Drawing** must be claimed as outlined in the paragraphs above entitled **Louisiana Lottery SAINTS 2nd-CHANCE DRAWING**.

TICKET VALIDATION REQUIREMENTS

To be a valid "NEW ORLEANS SAINTS" Scratch-off Game ticket, all of the following requirements must be met:

- (1) Exactly five (5) WINNING NUMBERS Play Symbols, five (5) WINNING NUMBERS Play Symbol Captions, fifteen (15) YOUR NUMBERS Play Symbols, fifteen (15) YOUR NUMBERS Play Symbol Captions, fifteen (15) Prize Symbols, fifteen (15) Prize Symbol Captions, one (1) PDF 417 Bar Code and one (1) Validation Number must appear beneath the scratch-off material in the rub-off area covered with security coating on the face of the ticket;
- (2) The five (5) WINNING NUMBERS Play Symbols, five (5) WINNING NUMBERS Play Symbol Captions, fifteen (15) YOUR NUMBERS Play Symbols, fifteen (15) YOUR NUMBERS Play Symbol Captions, fifteen (15) Prize Symbols, fifteen (15) Prize Symbol Captions, one (1) PDF 417 Bar Code, one (1) Validation Number and one (1) Pack-Ticket Number must meet all of the following criteria:
 - (a) be printed in black ink in its entirety and be fully legible;
 - (b) be right-side-up and not reversed in any manner;
 - (c) be one (1) or more of those described in the previous paragraphs entitled DEFINITIONS;
 - (d) be printed in the specified font size and correspond precisely to the artwork for this scratch-off game on file at the Lottery;

Any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;

- (3) Exactly one (1) Prize Symbol and one (1) Prize Symbol Caption must appear on the line below each of the fifteen (15) YOUR NUMBERS Play Symbols and the Prize Symbol Caption must correspond to the Prize Symbol under which it appears;
- (4) The ticket must be intact. Any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;
- (5) The ticket must not be mutilated, altered, unreadable, reconstructed or tampered with in any manner;
- (6) The ticket must not be counterfeit;
- (7) The ticket must have been issued by the Lottery in an authorized manner and must not be stolen nor appear on any list of voided tickets on file at the Lottery;
- (8) The ticket must be complete and have exactly: one (1) ten (10) digit Validation Number, five (5) WINNING NUMBERS Play Symbols, five (5) WINNING NUMBERS Play Symbol Captions, fifteen (15) YOUR NUMBERS Play Symbols, fifteen (15) YOUR NUMBERS Play Symbol Captions, fifteen (15) Prize Symbols, fifteen (15) Prize Symbol Captions, one (1) PDF 417 Bar Code and one (1) Pack-Ticket Number printed on the back of the ticket. Any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;

- (9) The Validation Number and Pack-Ticket Number of an apparent winning ticket must be confirmed by the Lottery as that of a winning ticket and shall not have previously been paid;
- (10) The ticket must not be blank or partially blank, misregistered, defective, printed or produced in error;
- (11) The display printing must be regular in every respect and correspond precisely with the artwork for this game on file at the Lottery;
- (12) The ticket must pass all validation tests of the Lottery;

Any ticket not passing all the validation tests in this section may be decreed void and ineligible for any prize. In the event a defective ticket is purchased, the sole responsibility and/or liability of the Lottery shall be the replacement of the defective ticket with an unplayed ticket(s) of equivalent sales price from any current lottery game.

CHILD SUPPORT ARREARAGE

According to Louisiana Revised Statutes 47:9026, the Louisiana Lottery is required to withhold outstanding child support arrearage from lottery winners. If the information submitted by the Department of Child and Family Services indicates that a prize winner owes child support, the amount due will be deducted from the winnings and the remainder, if any, will be remitted to the winner. Refer to the LLC's Special Rules and Regulations on Payment of Prizes for additional information regarding this matter.

The Lottery, subject to the Child Support Arrearage withholding requirements, reserves the right to award a cash prize equivalent to the value of a Saints Prize Package in lieu of the prize. In that event, the Saints Prize Package will be awarded to the next eligible entry drawn.

DISPUTES

In the event a dispute between the Lottery and the ticket presenter occurs as to whether the ticket is a winning ticket and the ticket prize is not paid, the President may, solely at his/her option, replace the disputed ticket with an unplayed ticket (or tickets of equivalent sales price from another current Lottery game). This shall be the sole and exclusive remedy of the presenter of the ticket in the event of such disputes.

GOVERNING LAW

In purchasing a ticket, the purchaser agrees to comply with and abide by Louisiana State Law and all rules and regulations, directives and final decisions of the Lottery and all procedures established by the President for the conduct of the game.

PURCHASE AND PRIZE RESTRICTIONS

No Scratch-off Game ticket shall be purchased by and no prize paid to any member of the Board of Directors, officer or employee of the Lottery or to any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any such person.

TERMINATION OF THE GAME

The President at any time may announce an end of sales date for the game. No tickets for this game shall be distributed to retailer locations following that date.


RETAILER CONDUCT

Retailers shall sell their tickets in sequential order within a Pack.

Retailers are prohibited from exchanging Packs with other Retailers.

Retailers are prohibited from playing Scratch-off Game tickets using any method other than fair chance or contrary to the principle that every ticket has an equal and random chance of winning a prize.

Retailers and retailers' employees are prohibited from placing their own or any other name on any ticket not purchased and redeemed by said retailer or employee.
