LOUISIANA LOTTERY CORPORATION GOLDEN NUGGET® SCRATCH-OFF GRAND PRIZE EVENT DIRECTIVE

OVERVIEW

This document details the reveal of additional prizes to be announced by the Louisianna Lottery to the Louisiana Lottery Golden Nugget® VIP Prize Package Event Second-Chance Winners. Both the 2nd -Chance drawing to determine the winners that will attend the event (performed by the Louisianna Lottery Corporation at their Offices in Baton Rouge), as well as the additional prizes to be awarded are the sole responsibility of the Louisianna Lottery Corporation; this is a Louisiana Lottery Corporation promotion. Golden Nugget Lake Charles, LLC shall have no responsibility for any prize selection or award. All prizes will be selected, awarded and paid by the Louisiana Lottery Corporation.

These Rules govern the additional prizes to be awarded to the Golden Nugget® VIP Prize Package Event Second-Chance Promotion winners who will attend an event at the Golden Nugget Lake Charles Hotel and Casino in Lake Charles, Louisiana on March 7-9, 2025. To be selected as one of the ten (10) winners, players must purchase any one of the following Louisiana Lottery tickets and enter the second-chance drawings as per Louisiana Lottery Golden Nugget® Scratch-off 2nd-Chance Drawing Directive:

- 1548 Golden Nugget® \$14,000
- 1549 Golden Nugget® \$100,000
- 1550 Golden Nugget® \$200,000

The ten (10) winners will be selected and verified by the Louisiana Lottery Corporation* and will be invited to attend the event as detailed below.

* Prohibited persons or individuals who have self-excluded from casino gaming activities at casino gaming establishments regulated by the Louisiana Gaming Control Board are not eligible to participate in the VIP Prize Package Event Second-Chance Promotion. The Louisiana Lottery Corporation will verify that the winner is at least 21 years of age. If any winner is determined to be under 21 years of age they will be disqualified.

Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners (or assigned proxy) will participate in up to three (3) rounds of prize reveals – Round #1; Round #2; and the Grand Finale Round. These are elimination rounds to get to one (1) Finalist. Once winners are selected in any round, they win the associated prize as detailed below and are eliminated from advancing to subsequent rounds.

Note: Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners are NOT required to be present at the event or have a proxy present to be awarded their prize. If the Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners or a proxy is not present, the Lottery will appoint a proxy to make selection(s). Only the Golden Nugget® VIP Prize Package Event Second-Chance Promotion winners are eligible to win a prize in the Live prize selections. The Grand Prize Event winner's guest or proxy is not eligible to win a prize.

The event emcee should not be an employee or affiliate of the Golden Nugget Lake Charles, LLC.

THE EVENT

The Event will be held at the Golden Nugget Lake Charles Hotel and Casino, in Lake Charles, Louisiana on March 8, 2025, at approximately 6:00 p.m.

EVENT PRIZES*

There will be 4 prize levels awarded over 3 rounds**:

- Prize Level 1 \$500 (4 winners)
- Prize Level 2 \$1,000 (3 winners)
- Prize Level 3 10,000 (2 Winners)
- Prize Level 4 \$100,000 minimum with the chance to win \$1,000,000 (1 winner)
- * Every Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners will win a prize (minimum \$500) and the Grand Prize Finalist will win either \$100,000 or \$1,000,000. Each Golden Nugget® VIP Prize Package Event Second-Chance Promotion winner will win only one (1) prize.
- ** Once a winner is selected in any round, that person will win the associated prize as detailed below and is eliminated from advancing to subsequent rounds.

Each Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners was assigned a number (1-10). Their number is associated with the order in which they were randomly selected by the Louisiana Lottery in the VIP Prize Package Event Second-Chance drawing to select the Ten (10) Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners.

- Each Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winner will have a unique number (1-10) on their name tag.
- Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners will be called to make their selection from lowest number to highest number in all rounds.
- There will be props manufactured to replicate nuggets. For each prize selection round, there will be the number of nuggets that corresponds to the number of outcomes (as detailed below).
- Numbered Prize Envelopes will be displayed on a prize board. For each prize selection round, there will be the number of Prize Envelopes that corresponds to the number of outcomes (as detailed below).

Round #1 (10 contestants - eliminating 7; \$500 & \$1,000 winners)

Seven (7) winners will be randomly selected from the ten (10) eligible Golden Nugget® VIP Prize Package Event Second-Chance Promotion Winners to win a prize as follows:

- Four (4) winners will each be awarded a \$500 prize;
- Three (3) winners will each be awarded a \$1,000 prize; and,

The odds of winning a \$500 cash prize in Round #1 are 1 in 2.50. The odds of winning a \$1,000 cash prize in Round #1 are 1 in 3.33.

In the 1st Round, all 10 Finalists will randomly select a green nugget from the prospector's wagon which they will break open. Inside the nugget will be a number that corresponds to a prize envelope which will reveal the prize.

Round #2 (3 contestants - eliminating 2 [2 win \$10,000 and 1 moves on to the Grand Finale (Round #3)])

The three (3) remaining winners will make random selections and be awarded prizes as follows:

- Two (2) winners will be awarded a \$10,000 cash prize.
- One (1) winner will advance to the final round (minimum win of \$100,000 cash prize with a chance to win \$1,000,000 in Round 3).

The odds of winning a \$10,000 cash prize in Round #2 are 1 in 1.50. The odds of advancing to the final round are 1 in 3.00.

In the 2nd Round, three Finalists will randomly select a red nugget from the prospector's wagon which they will break open. Inside the nugget will be a number that corresponds to a prize envelope which will reveal the prize.

Grand Finale (Round #3) (1 contestant [minimum \$100,000 prize with a chance to win \$1,000,000])

• One winner will win either \$100,000 or \$1,000,000.

The odds of winning a \$1,000,000 cash prize in Round #3 are 1 in 190.

In the 3rd Round, the Finalist will randomly select two gold nuggets from the prospector's wagon which they will break open. Inside each nugget will be a number that corresponds to a gold prize envelope which will reveal a symbol, either a Golden Nugget symbol or a Louisiana Lottery logo symbol. If BOTH envelopes reveal a Golden Nugget symbol, the Finalist wins \$1,000,000. Any other combination wins \$100,000.

WINNER SELECTION RESPONSIBILITIES

The Louisiana Lottery will be responsible for winner selection in Round #1, Round #2, and in the Grand Finale (Round #3). Golden Nugget Lake Charles, LLC shall have no responsibility for any winner selection or prize awards.

The Drawing Coordinator, or his/her authorized designee, shall serve as the Drawing Official and shall oversee the conduct of winner selection in accordance with this directive. The event shall be witnessed by a member of the Legislative Auditor's staff. The Drawing Official and the Auditor will monitor and record the results of winner selection. The Drawing Official will have the responsibility of recording and distributing winner information to the appropriate parties and providing a report of the event. The event report must be signed by both the Drawing Official and the Auditor and shall note any unusual occurrences or variations from the procedures outlined herein, and shall include the names and initials of any other official witness or participant in the drawing.

PRE-WINNER SELECTION PROCEDURES

In the presence of the Drawing Official and Auditor, preparation for Louisiana Lottery Golden Nugget[®] Scratch-Off Grand Prize Event will be conducted in two components; the first, preparation of nuggets for Rounds 1-3 and second, the insertion of prize amounts in envelopes for Rounds 1-3.

- 1) The first stage will begin with the insertion of sequential numbers in nuggets for each Round:
 - a. Round 1: Slips of paper will be prepared each containing a number from 1-10. The Drawing Official and Auditor will review and confirm that there are exactly 10 slips of paper numbered 1-10 and then will observe as each sequentially numbered slip of paper is rolled and inserted into the designated slot of ten green nuggets. Each nugget will be sealed.
 - b. Round 2: Slips of paper will be prepared each containing a number from 1-3. The Drawing Official and Auditor will review and confirm that there are exactly 3 slips of paper numbered 1-3 and then will observe as each sequentially numbered slip of paper is rolled and inserted into the designated slot of three red nuggets. Each nugget will be sealed.
 - c. Round 3: Slips of paper will be prepared each containing a number from 1-20. The Drawing Official and Auditor will review and confirm that there are exactly 20 slips of paper numbered 1-20 and then will observe as each sequentially numbered slip of paper is rolled and inserted into the designated slot of twenty gold nuggets. Each nugget will be sealed.

The nuggets will be secured until the event.

- 2) The second stage will begin with the insertion of prize amounts into colored envelopes for each Round:
 - a. Round 1: Ten green envelopes. Sequentially numbered labels 1-10. Prize message inserts will be prepared with the following prizes:
 - i. Four (4) \$500 prizes
 - ii. Three (3) \$1,000 prizes
 - iii. Three (3) Advance to Round 2 messages

The Drawing Official and Auditor will review and confirm the prize messaging as outlined above and will observe as each prize message is folded and inserted into the green envelopes, sealed and sequentially numbered 1-10.

The ten prize message inserts will be tri-folded and shuffled to mix up the order of the prize messages. One-by-one each prize message insert will be randomly selected and inserted into a green envelope. Each green envelope will be sealed. The ten green envelopes will be shuffled then sequentially numbered 1-10.

The ten green envelopes will be secured in a numbered sealed bag until Round 1. The seal number will be logged in the Drawing Official's report.

- b. Round 2: Three red envelopes. Sequentially numbered labels 1-3. Prize message inserts will be prepared with the following prizes:
 - i. Two (2) \$10,000 prizes
 - ii. One (1) Advance to Round 3 message

The Drawing Official and Auditor will review and confirm the prize messaging as outlined above and will observe as each prize message is folded and inserted into the red envelopes, sealed and sequentially numbered 1-3.

The three prize message inserts will be tri-folded and shuffled to mix up the order of the prize messages. One-by-one each prize message insert will be randomly selected and inserted into a red envelope. Each red envelope will be sealed. The three red envelopes will be shuffled then sequentially numbered 1-3.

The three red envelopes will be secured in a numbered sealed bag until Round 2. The seal number will be logged in the Drawing Official's report.

c. Round 3: Twenty (20) gold envelopes will be sequentially numbered 1-20. Prize message inserts and security envelopes will be prepared by SCA Promotions in accordance with SCA Security Procedure and Guidelines.

The Drawing Official and Auditor will review and verify that there are exactly twenty (20) sequentially numbered 1-20 security envelopes and exactly twenty (20) prize message inserts as follows:

- Two (2) Golden Nugget symbols
- Eighteen (18) Louisiana Lottery logo symbols

In accordance with SCA Security Procedure and Guidelines, the SCA security representative alone will randomly select and insert one (1) prize message into each numbered security envelope and seal each security envelope.

The Drawing Official and Auditor will observe as each security envelope is folded and randomly inserted into the numbered 1-20 gold envelopes. Each gold envelope will be sealed.

The twenty (20) gold envelopes will be secured in a numbered sealed bag until Round 3. The seal number will be logged in the Drawing Official's report.

WINNER SELECTION MECHANICS

In the presence of the Drawing Official and Auditor, the Golden Nugget Grand Prize Event will be held in three Rounds.

Each Round will commence with preparing the stage for the Round by loading the prospector's wagon with the corresponding-colored nuggets for that Round and placing the corresponding-colored envelopes on the prize board.

ROUND 1

Round #1 - 10 Nuggets

- Each Nugget will contain a unique number from 1-10 corresponding to numbered envelopes on the prize board.
- Each envelope will contain a prize message:
 - o 3 Advance to Round 2
 - o 3 \$1,000 Winners
 - 4 \$500 Winners

In the presence of the Drawing Official and Auditor, the stage will be prepared for the Round:

- The ten green nuggets will be loaded into the prospector's wagon.
- The Drawing Official and Auditor will verify that the seal number on the bag containing the green envelopes matches the seal number on the Drawing Official's report. The seal will be removed, the bag will be opened and the ten green envelopes will be placed on the prize board.
- 1) One-by-one, each Round 1 Finalist, from lowest number to highest number (listed on their nametag), will be directed by the emcee.
- 2) As directed by the emcee, beginning with Finalist #1, each finalist will select a green nugget from a set of 10 green nuggets in the prospector's wagon.
- 3) The finalist will break the nugget open to reveal a number.
- 4) The emcee will then direct the Finalist to select the prize envelope that corresponds to the number in their nugget. The Finalist will hold the envelope until each of the ten finalists have an envelope.
- 5) Steps 1-4 will be repeated with finalists #2-10 until all ten finalists have an envelope.
- 6) As directed by the emcee, each finalist will open their envelope to reveal the Prize message contained within the envelope or advancement to Round #2.

ROUND 2

Round #2 - 3 Nuggets

- Each Nugget will contain a unique number from 1-3 corresponding to numbered envelopes on the prize board.
- Each envelope will contain a prize message:
 - 1 Advance to Round 3
 - 2 \$10,000 winners

In the presence of the Drawing Official and Auditor, the stage will be prepared for the Round:

- The three red nuggets will be loaded into the prospector's wagon.
- The Drawing Official and Auditor will verify that the seal number on the bag containing the red envelopes matches the seal number on the Drawing Official's report. The seal will be removed, the bag will be opened and the three red envelopes will be placed on the prize board.
- 1) One-by-one, each Round 2 Finalist, from lowest number to highest number (listed on their nametag), will be directed by the emcee.
- 2) As directed by the emcee, beginning with the lowest numbered finalist, each finalist will select a red nugget from a set of 3 red nuggets in the prospector's wagon.
- 3) The finalist will break the nugget open to reveal a number.
- 4) The emcee will then direct the Finalist to select the prize envelope that corresponds to the number in their nugget. The Finalist will hold the envelope until each of the three finalists have an envelope.
- 5) Steps 1-4 will be repeated with each finalist until all three finalists have an envelope.
- 6) As directed by the emcee, each finalist will open their envelope to reveal the Prize message contained within the envelope or advancement to Round #3.

ROUND 3

Grand Finale (Round #3) - 20 Nuggets

- Each Nugget will contain a unique number from 1-20 corresponding to numbered envelopes on the prize board.
- Each envelope will contain a prize message:
 - o 2 Golden Nugget symbols
 - o 18 Louisiana Lottery logo symbols

In the presence of the Drawing Official and Auditor, the stage will be prepared for the Round:

- The twenty gold nuggets will be loaded into the prospector's wagon.
- The Drawing Official and Auditor will verify that the seal number on the bag containing the gold envelopes matches the seal number on the Drawing Official's report. The seal will be removed, the bag will be opened and the twenty gold envelopes will be placed on the prize board.

- 1) The finalist will select any two (2) of the twenty (20) nuggets.
- 2) Once the two nuggets are selected by the Finalist, and directed by the event emcee, the Finalist will break the nuggets open to reveal two (2) numbers, one (1) in each nugget.
- 3) The emcee will then direct the Finalist to select the two prize envelopes that correspond to the numbers in their nuggets.
- 4) When directed by the emcee, the Finalist will open one of the envelopes to reveal the prize message contained within that envelope.
- 5) If the Louisiana Lottery logo is revealed, the finalist wins \$100,000.
- 6) If the Golden Nugget symbol is revealed, emcee will direct the Finalist to open the second envelope to reveal the prize message inside that envelope. If the Louisiana Lottery logo is revealed, the finalist wins \$100,000. If the Golden Nugget symbol is revealed, the finalist wins \$1,000,000.

The "\$1 MILLION" prize shall ONLY be awarded if both Finalist selections contain the "GOLDEN NUGGET" symbol. In no event may more than two (2) envelopes be opened during the Final Round.

POST-WINNER SELECTION

At the conclusion of the event, following Round 3, the SCA security representative will retrieve the opened and unopened envelopes from the prize board and the Round 3 Finalist. If two (2) Golden Nugget symbols were not revealed during Round 3, the unopened gold envelopes from Round 3 will be opened in the presence of the Drawing Official and the Legislative Auditor to review and confirm the contents of the twenty gold envelopes, including the previously opened envelope(s) from Round 3 contain:

- o 2 Golden Nugget symbols
- 18 Louisiana Lottery logo symbols

DRAWING REPORT

Within 72 hours after the drawing, the drawing officer must submit a report to the president on a prescribed form that notes the observance of all procedures, any variations from the procedures, and includes the names and initials of all official drawing participants and witnesses.
