"PLAY OH!" tickets shall be made available for sale at the discretion of the President of the Louisiana Lottery Corporation and shall continue until the President publicly announces the termination date. This Directive shall govern play of the game, except to the extent that it may be amended or superseded by subsequent directive(s). The price of each ticket shall be five dollars (\$5.00) unless authorized by the President at a discount for promotional purposes.

Each ticket has one (1) game that consists of five (5) WINNING NUMBERS play symbols, fifteen (15) YOUR NUMBERS play symbols and fifteen (15) prize symbols. The ticket purchaser will remove the scratch-off material to reveal five (5) WINNING NUMBERS play symbols and captions, fifteen (15) YOUR NUMBERS play symbols and captions, and fifteen (15) prize symbols and captions.

Match any of YOUR NUMBERS to any WINNING NUMBERS, win PRIZE shown. Reveal a "STACK OF BILLS" symbol, win DOUBLE the PRIZE shown. Reveal a "STATE" symbol, win TRIPLE the PRIZE shown!

Beginning April 27, 2026, the Louisiana Lottery Corporation will conduct three (3) Second-Chance Drawings to award thirty (30) \$3,500 cash prizes as set forth in the **Louisiana Lottery 35<sup>th</sup> Anniversary 2nd-Chance Drawing Directive**. A valid entry is at least \$10 worth of any 35<sup>th</sup> Anniversary-branded \$1 Louisiana Treasures (game #1665), \$2 Say It Louisiana (game #1666), \$3 Taste of LA (game #1667), \$5 Play Oh! (game #1668), \$10 It's a Louisiana Thing (game #1669) scratch-off tickets and/or \$1 Louisiana Treasures (game #100292), \$10 It's a Louisiana Thing (game #100293) fast play tickets. Players may enter multiple times, but each entry must be mailed separately. Entrants may only win one (1) prize per drawing. The odds of being selected in the Louisiana Lottery 35<sup>th</sup> Anniversary 2nd-Chance Drawing will depend on the number of entries received for each drawing.

By entering the second-chance drawing, entrants grant the Louisiana Lottery permission to use their name, images and city of residence in its publicity efforts should their entry be selected as a prize winner.

The game consists of approximately 1,680,000 tickets printed for distribution. The anticipated number of winners and the value of these prizes, along with the approximate odds of winning are shown on the following page.

**DEFINITIONS**

- (a) **Lottery** means The Louisiana Lottery Corporation.
- (b) **President** means the President of the Louisiana Lottery Corporation or any other person to whom the President's authority is lawfully delegated.
- (c) A **Pack** shall consist of fifty (50) fanfolded tickets bearing a common pack number.
- (d) **Pack-Ticket Number** means the thirteen (13) digit code printed in black standard pack-ticket number font located on the back of the ticket in the format of GGGG-PPPPPP-TTT. The first four (4) digits are the Game Identifier, the fifth through tenth digits are the Pack Number, and the eleventh through thirteenth digits are the Ticket Number.
- (e) **Validation Number** means the ten (10) digit number imaged on the face of every ticket and covered with scratch-off material. The Validation Number shall be printed in standard Validation Number font.
- (f) **PDF417 Bar Code** means the bar code printed on the front of the ticket and covered with scratch-off material. This bar code will identify it as a winner or non-winner.

## **REDEMPTION**

Tickets winning a cash prize may be redeemed at any lottery office or retailer sales location during the official sales period for this game, but no later than ninety (90) days after the announced end of sales for this game. Tickets winning a low or mid-tier prize may be redeemed at any participating lottery retail location. Any cash prize may be redeemed at any lottery regional office or at lottery headquarters in Baton Rouge, within the claim period noted above. Tickets winning a FREE TICKET may be redeemed only at a participating lottery retail location and may be redeemed for a free instant-win ticket of equivalent sales price from any current active instant-win game within the claim period noted above. - d) The holder of a ticket shall be entitled to a prize of \$15.00 if the "STATE" play symbol and confirming "TRIPLE" play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$5.00 prize symbol and confirming FIVE prize symbol caption appear for that YOUR NUMBER in the exposed play area.
- e) The holder of a ticket shall be entitled to a prize of \$15.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$15.00 prize symbol and confirming FIFTEEN prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- f) The holder of a ticket shall be entitled to a prize of \$20.00 if four (4) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$5.00 prize symbol and confirming FIVE prize symbol caption appear for each matching YOUR NUMBER in the exposed play area.
- g) The holder of a ticket shall be entitled to a prize of \$20.00 if the "STACK OF BILLS" play symbol and confirming "DOUBLE" play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$10.00 prize symbol and confirming TEN prize symbol caption appear for that YOUR NUMBER in the exposed play area.

- r) The holder of a ticket shall be entitled to a prize of \$100.00 if fifteen (15) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$5.00 prize symbol and confirming FIVE prize symbol caption appear for twelve (12) matching YOUR NUMBERS **and** a \$15.00 prize symbol and confirming FIIFTEEN prize symbol caption appear for two (2) matching YOUR NUMBERS **and** a \$10.00 prize symbol and confirming TEN prize symbol caption appear for one (1) matching YOUR NUMBER in the exposed play area.

- s) The holder of a ticket shall be entitled to a prize of \$100.00 if ten (10) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$10.00 prize symbol and confirming TEN prize symbol caption appear for each matching YOUR NUMBER in the exposed play area.

- w) The holder of a ticket shall be entitled to a prize of \$250.00 if five (5) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$50.00 prize symbol and confirming FIFTY prize symbol caption appears for each matching YOUR NUMBER in the exposed play area.
- x) The holder of a ticket shall be entitled to a prize of \$250.00 if the "STACK OF BILLS" play symbol and confirming "DOUBLE" play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for that YOUR NUMBER **PLUS** one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$50.00 prize symbol and confirming FIFTY prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- y) The holder of a ticket shall be entitled to a prize of \$250.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$250 prize symbol and confirming 2HUNFTY prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.
- z) The holder of a ticket shall be entitled to a prize of \$500.00 if the "STATE" play symbol and confirming "TRIPLE" play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for that YOUR NUMBER **PLUS** the "STACK OF BILLS" play symbol and confirming "DOUBLE" play symbol caption appear as one (1) of the fifteen (15) YOUR NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for that YOUR NUMBER in the exposed play area.
- aa) The holder of a ticket shall be entitled to a prize of \$500.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$500 prize symbol and confirming 5HUN prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.

- bb) The holder of a ticket shall be entitled to a prize of \$1,000.00 if fifteen (15) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for five (5) matching YOUR NUMBERS **and** a \$50.00 prize symbol and confirming FIFTY prize symbol caption appears for ten (10) matching YOUR NUMBERS in the exposed play area.
- cc) The holder of a ticket shall be entitled to a prize of \$1,000.00 if ten (10) of the fifteen (15) YOUR NUMBERS match any of the WINNING NUMBERS and a \$100 prize symbol and confirming 1HUN prize symbol caption appear for each matching YOUR NUMBER in the exposed play area.
- dd) The holder of a ticket shall be entitled to a prize of \$1,000.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$1,000 prize symbol and confirming 1THOU prize symbol caption appear for that matching YOUR NUMBER in the exposed play area
- ee) The holder of a ticket shall be entitled to a prize of \$135,000.00 if one (1) of the fifteen (15) YOUR NUMBERS matches any of the WINNING NUMBERS and a \$135,000 prize symbol and confirming 135THOU prize symbol caption appear for that matching YOUR NUMBER in the exposed play area.

#### **TICKET RESPONSIBILITY**

- (a) A Scratch-off Game ticket is payable to the person presenting the ticket for payment.
- (b) The Lottery shall not be responsible for lost or stolen Scratch-off Game ticket(s).
- (c) The Lottery shall not be responsible for tickets claimed in error or redeemed in error at a sales agent location.

#### **CLAIM PERIOD**

All prizes for this Scratch-off Game must be claimed no later than ninety (90) days from and after the announced end of sales date for this game. Any prize not claimed in the manner described in the Directive and on the back of each ticket shall be forfeited.

All **Louisiana Lottery 35<sup>th</sup> Anniversary 2nd-Chance Promotion** prizes must be claimed as outlined in the paragraphs above, entitled **Louisiana Lottery 35<sup>th</sup> Anniversary 2nd-Chance Promotion**.

## TICKET VALIDATION REQUIREMENTS

To be a valid "PLAY OH!" Scratch-off Game ticket, all of the following requirements must be met:

- (1) Exactly five (5) WINNING NUMBERS Play Symbols, five (5) WINNING NUMBERS Play Symbol Captions, fifteen (15) YOUR NUMBERS Play Symbols, fifteen (15) YOUR NUMBERS Play Symbol Captions, fifteen (15) Prize Symbols and fifteen (15) Prize Symbol Captions, one (1) Validation Number and one (1) PDF417 Bar Code, must appear beneath the scratch-off material in the rub-off area covered with security coating on the face of the ticket;
- (2) The five (5) WINNING NUMBERS Play Symbols, five (5) WINNING NUMBERS Play Symbol Captions, fifteen (15) YOUR NUMBERS Play Symbols, fifteen (15) YOUR NUMBERS Play Symbol Captions, fifteen (15) Prize Symbols and fifteen (15) Prize Symbol Captions, one (1) PDF417 Bar Code, one (1) Validation Number and one Pack-Ticket Number must meet all of the following criteria:
  - (a) be printed in black ink in its entirety and be fully legible;
  - (b) be right-side-up and not reversed in any manner;
  - (c) be one (1) or more of those described in the previous paragraphs entitled DEFINITIONS;
  - (d) be printed in the specified font size and correspond precisely to the artwork for this Game on file at the Lottery;

Any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;

- (3) Exactly one (1) Prize Symbol and one (1) Prize Symbol Caption must appear on the line below each of the fifteen (15) Play Symbols and the Prize Symbol Caption must correspond to the Prize Symbol under which it appears;
- (4) The ticket must be intact; any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;
- (5) The ticket must not be mutilated, altered, unreadable, reconstructed or tampered with in any manner;
- (6) The ticket must not be counterfeit;
- (7) The ticket must have been issued by the Lottery in an authorized manner and must not be stolen nor appear on any list of voided tickets on file at the Lottery;
- (8) The ticket must be complete and have exactly: one (1) Validation Number, five (5) WINNING NUMBERS Play Symbols, five (5) WINNING NUMBERS Play Symbol Captions, fifteen (15) YOUR NUMBERS Play Symbols, fifteen (15) YOUR NUMBERS Play Symbol Captions, fifteen (15) Prize Symbols and fifteen (15) Prize Symbol Captions and one (1) PDF417 Bar Code, revealed in the play area and one (1) Pack-Ticket Number printed on the back of the ticket. Any deviation thereof must be submitted for claim to a Louisiana Lottery Corporation Office;

- (19) The Validation Number, one (1) PDF417 Bar Code, and Pack-Ticket Number of an apparent winning ticket must be confirmed by the Lottery as that of a winning ticket and shall not have previously been paid;
- (10) The ticket must not be blank or partially blank, misregistered, defective, printed or produced in error;
- (11) The display printing must be regular in every respect and correspond precisely with the artwork for this game on file at the Lottery;
- (12) The ticket must pass all validation tests of the Lottery;

Any ticket not passing all the validation tests in this section may be decreed void and ineligible for any prize. In the event a defective ticket is purchased, the sole responsibility and/or liability of the Lottery shall be the replacement of the defective ticket with an unplayed ticket(s) of equivalent sales price from any current lottery game

### **CHILD SUPPORT ARREARAGE**

According to Louisiana Revised Statutes 47:9026, the Louisiana Lottery is required to withhold outstanding child support arrearage from lottery winners. If the information submitted by the Department of Child and Family Services indicates that a prize winner owes child support, the amount due will be deducted from the winnings and the remainder, if any, will be remitted to the winner. Refer to the LLC's Special Rules and Regulations on Payment of Prizes for additional information regarding this matter.

According to Louisiana Revised Statutes 47:9026, the Louisiana Lottery is required to withhold outstanding child support arrearage from lottery winners. If the information submitted by the Department of Child and Family Services indicates that a 35<sup>th</sup> Anniversary Second-Chance prize winner owes child support, the amount due will be deducted from the winnings as applicable and the remainder, if any, will be remitted to the winner. Refer to the LLC's Special Rules and Regulations on Payment of Prizes for additional information regarding this matter.

### **DISPUTES**

In the event a dispute between the Lottery and the ticket presenter occurs as to whether the ticket is a winning ticket and the ticket prize is not paid, the President may, solely at his/her option, replace the disputed ticket with an unplayed ticket (or tickets of equivalent sales price from another current Lottery game). This shall be the sole and exclusive remedy of the presenter of the ticket in the event of such disputes.

### **GOVERNING LAW**

In purchasing a ticket, the purchaser agrees to comply with and abide by Louisiana State Law and all rules and regulations, directives and final decisions of the Lottery and all procedures established by the President for the conduct of the game.

**PURCHASE AND PRIZE RESTRICTIONS**

No Scratch-off Game ticket shall be purchased by and no prize paid to any member of the Board of Directors, officer or employee of the Lottery or to any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any such person.

**TERMINATION OF THE GAME**

The President at any time may announce an end of sales date for the game. No tickets for this game shall be distributed to retailer locations following that date.

**RETAILER CONDUCT**

Retailers shall sell their tickets in sequential order within a Pack.

Retailers are prohibited from exchanging Packs with other Retailers.

Retailers are prohibited from playing Scratch-off Game tickets using any method other than fair chance or contrary to the principle that every ticket has an equal and random chance of winning a prize.

Retailers and retailers' employees are prohibited from placing their own or any other name on any ticket not purchased and redeemed by said retailer or employee.
